YOUR COMMITMENT

FLEXIBLE PAYMENT OPTIONS

- Bank draft a portion to employee: At enrollment, the bank information is collected – the Y charges the employee the cost for membership (minus the Y match). The employee would seek your contribution from you directly.
- Bank draft a portion to employee: At enrollment, the bank information is collected – the Y charges the employee the cost for membership (minus the Y match and the portion you are contributing). The Y would invoice you for your contribution portion.
- 100% Invoiced: The Y invoices you for the full membership fee (minus the Y match) and you can decide if you want to charge the employee a portion on your end.
 - We would invoice monthly or quarterly.
